1. Reports

Clinical Physiologists Registration Board 1 April 2021 – 31st March 2022

1A HPCAA REPORT

The application for Clinical Physiologists to be regulated under the HPCAA is on hold by the Ministry of Health (MOH), at the request of the applicants. The board decided in 2020 to withdraw the current application for regulation in 2021.

The Board is working on formal recognition of self-regulation by the Ministry.

A future application for HPCAA regulation is not ruled out, and another application could be made if this were seen as necessary or desirable. It is not being actively pursued by the board at this time.

1B CHAIRPERSONS REPORT

Report presented at August 2021 AGM.

Another eventful year for the board and there is no doubt that the matter which occupied the most time and energy was the decision reached by the board to no longer pursue our application for regulation under the HPCAA. It would be fair to say that this was not an easy decision for the board to reach, but we do believe we have made the best decision for the professions we represent. Making this decision has enabled us to explore the option with the MOH to look at alternative options such as MOH recognition as a self-regulated profession.

We have started the process of bench marking ourselves against other boards especially in relation to policies and procedures to ensure we are operating at an appropriately high standard.

I am also excited about the changes we are making with regards to our professional presentation, and I call your attention to the new logo we have adopted after engaging a graphic designer. We are also in the early stages of working with a company to establish a new website. The company we have engaged with has worked with other registration boards so it is very exciting to be involved in developing something that will meet the needs of our registrants and it is our hope that eventually we will have something that simplifies the process for auditing of portfolios.

Auditing of portfolios is a huge role that has a significant time commitment, and the board is concerned that the current system does not meet the needs of our registrants in that the auditing is slow, and results can be delayed. We are addressing this by developing the role of a Portfolio Auditor who will be responsible for the planning, collation, and auditing of portfolios across the different professions.

The board has developed a vaccination statement around clinical physiologists undertaking COVID vaccination roles, and this can be found on the website.

The board continues to work with the professional societies whom we represent and there is a lot of discussion occurring this year around qualifications, training pathways and workforce planning. I welcome all these discussions as it helps to promote our professions and ensures we are included in the discussions which can impact on future development.

Lastly, I would like to thank the board members for the hard work and dedication that have shown over this last year, it has been a busy but rewarding year. I look forward to working with the board as we move into another challenging year.

REGISTRARS REPORT

Report presented at August 2021 AGM

It has been a busy year as Registrar with moves towards building a new website and a logo design in addition to the usual workload.

Statistical breakdown of Register 31/3/21

Total Registered: 488 (prev 476) with 44 new registrations.

- Total with current APC: 410 (prev 352)
- Total with overdue, lapsed or no APC: 55 (prev 45)
- On hold (Parental leave): 8 (prev 7)
- Non-Resident: 15 (prev 19)
- Supervised: 67 (prev 70)

Scopes of Practice:

- Cardiac registrants: 259 (prev 253) 53%
- Renal registrants: 74 (prev 78) 15%
- Respiratory registrants: 56 (prev 50) 11%
- Exercise 40 (prev 38) 8%
- Sleep registrants: 37 (prev 35) 8%
- Neuro 22 (prev 22) 5%

For the first year we have counted how many cardiac physiologists registered with CPRB perform echocardiography as part or all of their role: 38 (29%). This was by self-declaration. There were approximately 58 registered with MRTB in 2020 as Sonographers limited to Cardiac sonography, but it is unknown how many are registered with both boards, and how many sonographers not limited to cardiac echo do perform echocardiography.(MRTB 2021 Annual report not available at time of writing).

Applications:

Registrations: There were 44 new applications. 0 applications were declined, and 1 was abandoned due to failure to complete the process.

PCAs: 1 competency assessment in Echocardiography was performed.

APCs: The staggered renewals with Cardiac renewing in May, Renal in July, and all others by September continued to work well. This year it was made compulsory to have photo ID and a CV loaded to the registrant profile, to gather missing information, and have updated details for registrants.

More statistical detail is available in the Annual Report.



CPRB Website: The 'Wild Apricot' website (US) has served its purpose to keep automatic reminders going out, provide a real-time register, and store records of registrants. Its limitation is the inability to customize most functions or terminology, meaning we have had to 'bend' it's core functions to suit our needs. The project to have a customized website specifically for our needs, by a NZ company Gecco with local support, is therefore very exciting.

Portfolios:96 portfolio audits were undertaken, and feedback provided as required. A small number re-submitted following this feedback in the same year or were asked to make changes and undergo re-audit in the following year. It has been challenging for me to manage the audits across 6 professional groups, and for the board members auditing to fit this into their spare time. The decision to appoint a paid auditor was made and it is hoped this will deliver better communication and feedback to those audited. In addition, a CPD module will be part of the new website and will aim to streamline portfolio audits for both registrants and auditors.

3A SUMMARY OF PROJECTS AND ACTIVITIES

POLICY

Covid-19 Vaccinator training statement was published.

Clinical Supervision: A statement clarifying terminology, definitions and expectations is in progress. Benchmarking of CPRB practices and policies with equivalent registration bodies took place in 2021. Clarification for eligibility for registration for Respiratory Therapists added to website. Clarification for pathway for overseas trained Sleep Physiologists requirements for NZ registration.

ADMINISTRATIVE

Appointment of a new Registrar and Portfolio Officer – recruitment, interviews, selection and training undertaken.

New member administration website instituted. This involved updating of all website pages, a new logo design, creation of new APC processes, creation of a CPD audit module, new Registration process, retrieval of documents uploaded to old platform, transfer of data to new website, new process document creation for members, board and staff.

Auditing of Cardiac, Renal, Sleep, Neuro and Clinical Exercise portfolios was undertaken.

Four board meetings and AGM held via Zoom.

GENERAL

Meetings with the Allied Health Director to pursue formal recognition of self-regulation took place. Attendance at Allied Health Huis, discussing workforce issues, self-regulation, and educational pathways.

Work towards the feasibility of offering Sleep extended practices (for those practicing some aspects of Sleep scope, but are not Sleep Physiologists) was ongoing.

Engagement with Otago University sought to support MTechs modules for Respiratory Physiologists. Renal Physiologists engaged AUT to provide their qualification.

Board Honoraria was proposed and accepted at the 2021 AGM.

3B PRIORITIES FOR YEAR AHEAD

POLICY

Review of policies with regard to self-regulation, mirroring HPCAA regulations where appropriate.

ADMINISTRATIVE

Update all profiles with documents from file. Show all historical names on the public register. Embed and improve new APC and audit processes, and related documentation.

GENERAL

Continue to engage with Ministry of Health to pursue formal recognition of self-regulated professions.

Benchmarking exercise to compare practices with other boards to identify and action any improvements to processes or policy.

Constitution review – last reviewed 2014. This has become a priority due to the imminent legislation affecting Incorporated Societies.

4.Registrations

4A REGISTRATIONS AS AT 31/3/22

The Clinical Physiologists Registration Board (CPRB) is the registration board set up for Clinical Physiologists employed in New Zealand. If the professional society that a person belongs to is represented by the CPRB then that person can apply for registration with the CPRB. Currently registration with the CPRB is voluntary. Notwithstanding the voluntary nature of registration with the CPRB, the registration process is set up to meet the standards and requirements of the Health Practitioner Competence Assurance Act (2003).

Registration is awarded to a clinical physiologist when the CPRB is satisfied that the applicant meets specific competencies for a professional Scope of Practice.

When Registration is awarded the member's name is listed on the public Register of Clinical Physiologists

Discussion

A smaller number (48) of APCs were not renewed compared to the previous year (55). The APC renewal process changed to allow applicants to upload forms, however this didn't impact renewal numbers as much as hoped.

New registration numbers grew in all scopes except Neurophysiology, who did not register any new physiologists. Fewer non-residents registered, presumably because job prospects in NZ were nil due to Covid-19 border rules.

Cardiac and renal physiologists remain the largest groups.

Cardiac physiologists who perform echocardiography as measured by self-declaration dropped to 26% from 29% the prior year. 71 physiologists perform echo as all or part of their duties.

A larger proportion of physiologists require supervision – 21% from 16% last year.

5B AUDITS 31/3/22

CPRB requests full portfolio submission of a percentage of APC holders every year. This percentage varies across professional groups which are disparate in size. The purpose of auditing portfolios is to review the level and complexity of Continuing Professional development, and that this is appropriate to the physiologist's scope of practice and experience.

Failure to submit a portfolio can result in withdrawal or withholding of the practitioner's APC.

Practitioners submitting a portfolio considered inadequate in some way, are advised and supported to achieve an appropriate level of CPD. This is reviewed after a mandated period of time.

In the year 1/4/21- 31/3/22 14% of registrants holding an APC were audited.

All re-submissions passed a 2nd audit.

16 Registrants audits were deferred.

7 Failed to respond to audit - of these some were no longer practicing but had not informed CPRB.

2 annual practicing certificates were withdrawn or withheld due to not complying with the audit.

Discussion:

2021 was a catchup year for Cardiac audits. In the first half of his period CPRB had no dedicated portfolio officer, and it was felt another large Cardiac audit (usually over 70 portfolios) was not manageable, therefore only newer practitioners and those deferred from prior years were audited.

In the 2nd half of the year CPRB appointed its first portfolio manager Devina Pillay. Respiratory audits are scheduled to start in the first half of 2022.

7.Financial Report

7A INCOME

- Income \$ 56158.00 an increase on previous year.
- While more registration and APC fees were received, there was a reduction in interest income due to interest rates falling.

7B EXPENDITURE

- Expenditure: \$ 51118.00, a significant increase on previous financial year.
- No expenditure on travel due to holding all virtual meetings via. Less tax paid as less interest earned. Budgeted website running costs did not eventuate due to a delay in the rollout of the website due to Covid-19.
- More expenditure on: Admin costs increased due to funding the Portfolio manager position, training of new Registrar, and admin hours working on and transitioning to the new website. Board honoraria payments were agreed by the membership and paid for the first time. A capital investment was made in the purchase of customized software for the new website. The financial auditors fee decreased as a review was performed rather than an audit.
